**Appendix A - Glossary of Technical Terms**

**Glossary of Terms**

Ancient semi-natural woodland	Woodland which has occupied a particular site for a period in excess of 400 years.
Bat detector	Electronic device used to render the ultrasonic calls of a bat audible to the unaided human ear.
County Wildlife Sites (CWS)	The former classification for local wildlife sites, a non-statutory site of importance for nature conservation recognised by Northamptonshire County Council for planning purposes.
DAFOR	A <b>scale</b> used to try and measure the frequency and cover of the different plant species. DAFOR is a relative measure incorporating abundance and frequency.
DOMIN	A <b>scale</b> used to try and measure the frequency and cover of the different plant species. DOMIN provides a quantitative measure of abundance.
Great Crested Newt Habitat Suitability Index	A scoring system developed to evaluate the quality of habitats for great crested newts, based on the system proposed by Oldham <i>et al.</i> (2000) <sup>42</sup> .
Habitat	The natural home of an animal or plant.
Hibernaculum	A shelter in which a creature seeks refuge, especially during winter.
Holt or lay-up	The lair of an otter.
Local Nature Reserve (LNR)	Non-statutory habitats of local significance designated by local authorities where protection and public understanding of nature conservation is encouraged.
Local Wildlife Site (LWS)	A non-statutory site of importance for nature conservation recognised by Leicestershire, Northamptonshire and Warwickshire County Councils for planning purposes.
National Vegetation Classification (NVC)	The National Vegetation Classification is the standard classification used for describing vegetation in Britain. The NVC aims to describe all the vegetation of Great Britain. It is a phytosociological classification, which means that it classifies vegetation solely on the basis of the plant species of which it is composed <sup>32</sup> .
Phase 1 Habitat Survey	Standardised survey technique for recording specific habitats such as grasslands or woodlands. The procedures are set out in the Nature Conservancy Council Publication 'Handbook for Phase 1 Habitat Survey – A Technique for Environmental Audit, 1990' <sup>30</sup> .
Potential Local Wildlife Site (pLWS)	A non-statutory site of importance for nature conservation recognised by Leicestershire, Northamptonshire and Warwickshire County Councils for planning purposes.
Potential Site of Importance for Nature Conservation (pSINC)	the former classification for local wildlife sites, a non-statutory site of importance for nature conservation recognised by Leicestershire and Warwickshire County Councils for planning purposes.
RUDERAL	Literally 'growing in waste places'. Tall ruderal vegetation is a phase 1 habitat category which comprises of tall perennial or biennial broad-leaved plants, usually more than 25 cm high, of species such as rosebay willowherb. ( <i>Chamerion angustifolium</i> ), nettle ( <i>Urtica dioica</i> ) and Japanese knotweed ( <i>Polygonum cuspidatum</i> ) <sup>32</sup> Ephemeral/short perennial vegetation of disturbed, freely

	draining sites and often characterised by species such as great plantain ( <i>Plantago major</i> ), creeping buttercup ( <i>Ranunculus repens</i> ), white clover ( <i>Trifolium repens</i> ), black medick ( <i>Medicago lupulina</i> ), coltsfoot ( <i>Tussilago farfara</i> ) and other short plants may also be considered ruderal <sup>32</sup> .
Roost	Any site used by bats for rest, sleep, torpor, food digestion, breeding or shelter
Semi improved neutral grassland	Neutral grassland is typically enclosed and usually more intensively managed than acid or calcareous grassland (except on road verges), this phase 1 habitat category encompasses a wide range of grassland communities occurring on neutral soils (pH 5.5-7.0). Semi-improved grassland is a transition category made up of grasslands which have been modified by artificial fertilisers, slurry, intensive grazing, herbicides or drainage, and consequently have a range of species which is less diverse and natural than unimproved grasslands Handbook for Phase 1 habitat survey: a technique for environmental audit <sup>30</sup> .
Site of Importance for Nature Conservation (SINC)	The former classification for local wildlife sites, a non-statutory site of importance for nature conservation recognised by Leicestershire and Warwickshire County Councils for planning purposes.
Site of Special Scientific Interest	Areas of land identified by the statutory bodies, in accordance with their published guidelines, as being of particular value for their fauna and flora and geological and physiographic features. Their objective is to safeguard and enhance the characteristic plants, animals and physical features of our natural heritage. The SSSI designation covers important sites for nature conservation including those of national and international importance.
Sonogram	A visual display of the time (x-axis) and frequency (y-axis) components of a sound.
sp.	Abbreviation for species (singular) where plant or animal can only be identified to generic not specific level.
spp.	Abbreviation for species (plural) where plants or animals can only be identified to generic not specific level.
Spraint	Otter faeces.
subsp. Sub-species.	The sub-division of a species, usually caused by geographical isolation.
Time expansion	A technique, requiring a computer and suitable software, for transforming ultrasound of the kind produced by bats into a sonogram.
